INTRODUCTION

Biography

Richard Southwell Bourke was born on 21st February 1822 the eldest son of Robert Bourke and Anne Charlotte Jocelyn. He was educated at home in Hayes, county Meath until entering Trinity College, Dublin in 1841. After taking his degree he travelled in Russia, publishing an account of his tour; *St. Petersburg and Moscow: a Visit to the Court of the Czar* (1846). He married Blanche Julia Wyndham, daughter of George Wyndham, 1st Baron Leconfield in 1848. They had four sons and three daughters. In 1849 Robert Bourke inherited the Earldom of Mayo from his uncle John Bourke, 4th Earl Mayo and, as the eldest son, Richard assumed the courtesy title Lord Naas.

Richard Bourke was active in famine relief in Ireland in 1847 and entered parliament as a conservative MP for county Kildare, which seat he held until 1852. He sat for Coleraine (1852-7) and Cockermouth (1857-68). In 1852 he was appointed Chief Secretary for Ireland in the administration of Edward Smith-Stanley, 14th Earl Derby, although he only held the post for a matter of months before the governments collapse in December 1852. On the return of the Conservatives to power in 1858 Naas reassumed his position as Chief Secretary, and held the same position in the subsequent Conservative administration (1866-8). Naas also managed the Conservative party within Ireland, and was largely responsible for there success in the 1850s and 1860s.

As Chief Secretary Naas was described as efficient, loyal and dedicated. His tenure as Chief Secretary covered some of the most important issues in mid-nineteenth century Irish politics, and he showed himself amenable to situations as they arose. Initially opposing the disestablishment of the Church of Ireland, his views become less sectarian. Similarly with land reform, he came to support compensation for tenants for improvement made without their landlord's consent. He was, however, firm in his handling of the Fenian crisis in the late 1860s.

In 1868 on the death of his father, Naas succeeded to the Earldom of Mayo as the 6th Earl. Benjamin Disraeli selected him as Viceroy of India, a position he had long converted, and he was sworn in Calcutta in January 1869. As Viceroy he aimed to create a strong India by creating a cordon of friendly independent states outside the borders, and by securing the support of Indian princes. Internally he aimed to reduce mismanagement and improve the conditions and education of the population but with no idea of the possibility of any form of self-government for India. He worked extremely hard to obtain knowledge of India from junior officials upwards, and undertook long tours to secure first-hand knowledge. However, by 1870 dissatisfaction was growing with India, from rising income tax and within the religious minority Muslim and Sikh communities. In February 1872 Mayo was assassinated by a Muslim convict, as he inspected the penal colony of the Andaman Islands. His body was returned to Ireland and buried in Johnstown church, county Kildare.

Papers

This collection was acquired by the National Library of Ireland as a gift from the Hon. Bryan Bourke (third son of Walter Bourke, 8th Earl Mayo) in 1938, see *Report of the Trustees of the National Library of Ireland, 1838-9*.. The collection is principally comprised of official papers including correspondence, memorandum, reports and drafts of bills. There is also a very small collection of personal papers. The papers covers the period 1846-1873, with one document from 1795. The collection is contained within 96 boxes, with two outsized folders. The papers are generally in good condition. However, there are number of papers, mainly correspondence from the year 1867, which have been badly water damaged. This has cause the paper to become fragile and the writing unclear. In some cases the material is so badly damaged that it is not available for consultation.

Because the Library received this material in one large and complete donation there are only a handful of other items relating to Richard Bourke, 6th Earl Mayo within the library's collection; these are listed below:

Arrangement

The majority of this collection had previously been assigned manuscript numbers and a brief descriptions for listing in Hayes' *Manuscript Sources for the History of Irish Civilisation* (1965). However, when this listing was done 22 boxes were overlooked. These have now been catalogued and are available for consultation for the first time. For the majority this list follows the arrangement in Hayes, although where appropriate alterations have been made, as this list provides much greater detail. The previously overlooked material has been fitted into this structure, as it was of the same type. The papers have been arranged into four subgroups; the first containing official correspondence as Chief Secretary for Ireland, the second official papers as Chief Secretary for Ireland, the third papers as Viceroy of India and the fourth personal papers. Within each subgroup the papers have been separated by type or theme, and then arranged chronologically.

Assessment

The Mayo papers are an extensive and important collection covering in detail the period of Richard Bourke, 6th Earl Mayo's involvement in Irish political life. This cover the eventful years on the 1850s and 1860s, and the papers deal with issues of land reform, church reform, Fenianism, Phoenix societies, popular unrest and the condition of Ireland. In addition they also provide information on the administration of Ireland, notably the appointment to public service posts and the creation of the new Public Records Office (1866-8). Although the collection contains a huge amount of letters to Richard Bourke, 6th Earl Mayo there are few copies of letters from him. However, his correspondence with several important political figures are held in the collections of other institutions.

There is a very limited amount of papers relating to Richard Bourke, 6th Earl Mayo's time as Viceroy of India, as his Viceregal papers were deposited with Cambridge University Library. Equally there are very few personal papers or letters within the collection. Richard Bourke, 6th Earl Mayo's correspondence with his wife, Blanche Bourke neé Wyndham, Lady Mayo is also held by the Cambridge University Library.
