Deeds, wills, maps, plans and legal papers relating to the family of Doyne, formerly of Wells, Gorey, county Wexford, mainly concerning lands in the counties of Carlow, Kildare and Wexford, c. 1660-1939. [See pedigree of the family in Burke's Irish Family Records (1976)]. The collection was acquired by the National Library of Ireland from Mr F. M. Doyne in November 1975. NLI *Report on Private Collections* No. 5 lists other Doyne family papers (not acquired by the Library).
