INTRODUCTION

The Union

The history of the Irish Transport and General Workers' Union is in many senses the history of the modern Irish labour movement and was at the centre of the majority of industrial, organisational, political and personality issues involving Irish labour since its foundation at the beginning of the twentieth century. It was founded in January 1909 by James Larkin after his split with the National Union of Dock Labourers. In 1910 it was affiliated to the Irish Trades Union Congress and by 1911 it had a membership of 5,000. James Connolly was appointed as Belfast organiser in 1911. Under the Larkin leadership the ITGWU came into increasing conflict with many employers, most notably William Martin Murphy, who tried to prevent their employees joining. This led to the Dublin Lock Out (September 1913-February 1914) when Murphy and the Dublin Employers' Federation took the step of locking out trade union members from their employment. When the Lock Out ended as those temporarily unemployed resumed their jobs, the ITGWU was in financial peril and Larkin went to the United States to raise funds for it and the Labour Party. James Connolly took over the leadership in his absence. After the 1916 Rising Thomas Foran, T.D. Daly and William O'Brien attempted successfully to raise the profile of the ITGWU and attract new members, particularly in rural areas. Their success may be estimated from the fact that in 1919, the union had 350 branches with a membership of 100,000, a triumph which made the ITGWU the largest trade union in Ireland. However a dispute between Larkin and O'Brien served to undermine this success, and in 1923 Larkin left to lead the Workers' Union of Ireland. Almost 40,000 of the ITGWU members followed him in switching allegiance. This dispute led to further divisions. When Larkin affiliated with the Labour Party, O'Brien and the ITGWU left in 1945 and formed a rival National Labour Party. They also established the Congress of Irish Unions, a rival to the Irish Trade Union Congress. The breach between Larkin and O'Brien ended just twelve years after Larkin's death when the two congresses united to form the Irish Congress of Trade Unions in 1959 and later the ITGWU reaffiliated with the Labour party. In 1990 both the ITGWU and FWUI (Federated Workers' Union of Ireland) were disolved and the Services Industrial Professional Technical Union (SIPTU) was formed.

The Papers

The papers of the ITGWU have been divided into three sections. The papers relating to the union generally have been listed chronologically, as have the legal correspondence and accounts. The largest section of the collection concerns papers relating to ITGWU, Labour party and Trade Union conferences, and again have been listed and arranged chronologically. These are mainly correspondence, resolutions, lists of delegates, reports and agenda for meetings.
